CONDITIONS STIPULATED

ANNEXURE - A

1. The college should strictly adhere to the eligibility conditions prescribed by the University / Government for admission to the courses offered including the said courses(s). The course now granted is purely a Self-Financing one.
2. The college should not admit students over and above the sanctioned strength granted by the University.
3. No amount should be collected from the students in excess of the fees prescribed by the University / Government or donations for appointment of persons for both teaching and non - teaching posts.
4. The College should follow the Reservation Policy of the Tamil Nadu Government in admitting candidates and appointment of staff.
5. There shall be no financial commitment on the part of the State Government or University on account of the courses being started by the College.
6. The College should pay salary to the teachers as prescribed by the Government / UGC.
7. The College should provide accommodation and other facilities to the University to conduct examinations and for other academic purposes as and when required.
8. The students shall be permitted to appear for the First Semester Examination only after 90 working days from the date of receipt of this affiliation order.
9. The Management should get the Continuance of Affiliation for the above said courses every year.
10. The Management should obtain the approval from the University for the appointment of teaching staff.
11. The Management should select the Optional / Elective subjects for the above courses in consultation with the Controller of Examinations of the University.
12. Approval syllabus can be had from the University.
13. The Management should start the College / Course during the academic year, the provisional affiliation is granted, failing which the same should be reported to the University authorities immediately.
14. Such other conditions as may be prescribed from time to time should also be complied with.
